Since establishing operations in Cambodia in 1992 in the wake of decades of internal and regional conflict, MAG has been a leading contributor to the country's mine action sector, releasing over 118 million square meters of land back to impacted communities for the direct benefit of more than two million women, girls, men and boys. In a country where 80% of the population live in rural areas and are highly vulnerable to economic shocks, the presence of mine contamination continues to impede poverty reduction and development initiatives in mine-affected communities. MAG work in support of the Royal Government of Cambodia (RGC) to put land back into safe and productive use, and in support of the Landmine Free 2025 initiative.


With the generous 12-month funding from Terra Renaissance for the project 'Landmine survey and clearance to facilitate community development in Cambodia', MAG has deployed a Mechanical Operations Unit (MOU) to conduct technical survey and clearance of prioritized areas in Battambang province.



#### GOAL

To contribute to sustained poverty reduction and socio-economic development in landmine affected communities in rural Cambodia, through the release of safe land.

## PROJECT UPDATE

In the Q1 report submitted in July 2021, MAG requested Terra Renaissance to continue its co-support<sup>1</sup> of the Medium Mine Wolf (MMW) MOU in Battambang province due to the need of the Digger-250 MOU to undertake the clearance in Ratanakiri province. Terra Renaissance accepted MAG's request allowing MAG to transfer the support provided to co-support the Digger-250 MOU to MMW MOU starting from July 2021. MAG remains very grateful for the support and flexibility of Terra Renaissance.





During this reporting period (Q4), MAG MMW MOU conducted clearance activities on two minefields, one in Prey Totueng village of Koas Krala district and another in Ou Choam Kraom village of Samlout district, Battambang province as show in the map below. The team released 121,452m² of contaminated land and found and destroyed ten (10) anti-personnel mines.



There was no land reduced through technical survey during this quarter. The significant overachievement of the overall project land released target is primarily due to the additional land released through technical survey conducted by the MOUs in previous quarters.

MMW MOU undertook clearance on two minefield, one minefield (BS/CMAA/07141) in Prey Totueng village and another minefield (BS/CMAA/09378) in Ou Choam Kraom village, from January to March 2022. The clearance of the minefield (BS/CMAA/07141) in Prey Toteung village was completed on 6<sup>th</sup> February, 2022 and there were no new beneficiaries of this minefield reported during Q4 because the team already reported these in Q3. Minefield BS/CMAA/09378 in Ou Choam Kraom village commenced clearance activities on 4<sup>th</sup> January, 2022. The land is owned by 140 families with a total of 615 people (180 women, 181 men and 133 boys and 121 girls). The completion of this minefield will indirectly benefit a further 9,733 people from 2,040 households (2,468 women, 2,468 men, 2,396 boys and 2,401 girls). This contributes to achieving 448% of total project target on land beneficiaries. Release of the land leads to a significant overachievement on land release beneficiaries because the village is populous and the land highly productive.

## Project Outcomes and Impacts

Cassava has become Cambodia's second largest crop after rice and contributes over USD 1 billion to the economy each year. In 2021, Cambodia exported 2,793,729.92 tonnes of cassava, representing a 22.1 per cent increase from the previous year<sup>3</sup>. Battambang province is the country's leading producer of this industrial crop, employing tens of thousands of people in its farming and processing.

Battambang remains the most mine-affected province in Cambodia, as well as one of the poorest, with an estimated 85.5km2<sup>4</sup> of land contaminated by landmines. The majority of those benefitting from MAG's clearance operations are dependent on subsistence agriculture (the cultivation of rice, cassava, beans, maize, mango, cashew, corn and pepper) and collection of non-timber forest products as their primary livelihood activities. Communities live predominantly in remote areas with poor infrastructure, and have therefore very limited access to services. Restricted availability of agricultural land due to the presence of mine and explosive remnant of war contamination further impedes poverty reduction and development initiatives.

Funding from Terra Renaissance has made it possible for MAG's MOU to carry out the lifesaving clearance in Samlout and Koas Krala districts of Battambang province where majority of community members is heavily dependent on the cassava farm. The land released over the course of this project (April 2021-March 2022) is 595,896m2 of contaminated land in communities across Battambang province, having a great impact on the livelihood of the impacted communities. According to MAG's pre-clearance impact assessment conducted by a non-technical survey team, the released land will be used in its entirety to plant cassava and other crops.

## ADDITIONAL INFORMATION

MAG has over the course of the pandemic adapted to mitigate adverse effects of the pandemic (restrictions/outbreaks) and specifically the impact they may have on our operations by ensuring we maintain flexibility in changing operational cycles and implementing precautionary measures as guided by the Dept of Health, and we will continue implementing this in the following guarters.
